## **SUMMARY OF SURVEY RESPONSES**

- 1. Open space has financial implications for our town:
  - a) When the town acquires open space, no taxes are collected.
  - b) State acquired open space provides decreased taxes.
  - c) Land that becomes residential development collects taxes that rarely cover theservices provided.

## Please give your opinion on open space financing:

A majority of respondents are in favor of open space preservation for recreation and other uses, and a sub set of them understand the cost of residential **development**.

Some respondents could benefit from <u>education</u> with regard to alternative financing methods, purposes for conservation, preservation and need for recreational facilities.

Other respondents were in favor of open space preservation, but only in better **economic** times.

Some respondents thought that open space would help preserve the rural feel of Townsend, while other thought enticing industry to Town would help defray the cost of preservation.

There were four specific self-interests mentioned: horseback riding, ATV trails, rail trail, and areas with no hunting allowed.

# 2. The following are the Open Space and Recreation Goals from the 1999 Plan. Please rank the importance of these goals for you today and in the future.

To provide the ranking, the percentage of the categories Very Important and Important were combined.

- Maintain high quality drinking water for the residents of Townsend. (94.1%)
- > Ensure the quality, vibrancy, and continued usage of the Squannacook River and its tributaries. (92.5%)
- > Protect and maintain the quality of all surface waters in Townsend, including wetlands. (88.2%)
  - The goals and objectives established in 1999 are still relevant and dominant in the minds of the current residents.
  - o Water Quality Protection both above (Surface Waters) and below ground (Aquifer Protection) are at the top of the list in importance.
  - o A question about creating links between parcels spurred many comments about a linear recreational park through Townsend, the rail trail bike path.

## 3. Regarding your knowledge of Townsend's recreation and open space facilities:

- Responders felt they had good awareness of local recreation areas yet did not feel the town does a good job supplying information.
- More maps and information should be available, particularly web based information.
- 70% felt they were familiar with the town recreation areas. However 49% felt the town did a poor job of communicating about its open space and recreation areas
- Most thought the town should have more info available with 91% indicating need for maps

# 6. Townsend's rural character is enhanced by the wildlife that lives here. It is important to protect Townsend's wildlife by protecting important habitats such as:

less than 5% of the responses were strongly disagree or disagree with all questions and more than 75% of the responses were agree or strongly agree with the questions.

Travel corridors along rivers had the most people interested in protecting it (88% agreed or strongly agreed), with only 2% disagreeing or strongly disagreeing.

Forested land had almost the same number of people interested in protecting it as riverside land (87% agreed or strongly agreed), and fewer disagreeing with the statement (0.5% disagreed or strongly disagreed).

Unusual habitats and areas known to be used by rare species were the losers, with 77% of the respondents agreeing or strongly agreeing to protect them and 4% of the respondents disagreeing or strongly disagreeing.

Travel corridors between protected pieces of land, land beside water bodies as habitat for water-dependent animals, and open land were in the middle, with 83-85% of respondents agreeing or strongly agreeing that they should be protected and 2% disagreeing or strongly disagreeing.

But the majority of respondents wanted to protect all of the wildlife habitats mentioned.

Comments were split between those agreeing and disagreeing.

Some points that came up:

- Nuisance wildlife—beavers (1 person)
- Whether the respondent agreed or disagreed would depend on the method of protection (3 people). Taking away landowner rights was a no-no; buying land a possibility depending on price.
- Spend money on education rather than wildlife (2 people)
- A few comments seemed to show that the person was knowledgeable about wildlife and regulations (3).
- Only one person was unclear on the feasibility of wildlife protection techniques.

## 7. Need for recreation facilities in Townsend

Teen Center Bike Trail / Walking Paths Skateboard Park

- Out of 223 responses; 80 (35.9%) strongly agree/agree that they are satisfied with existing places for children to play and recreate in Townsend. 97 (43.5%) strongly disagree/disagree and 46 (20.6%) remain neutral.
- Out of 224 responses; 80 (35.7%) people strongly agree/agree that they are satisfied with the places available in Townsend for recreational use by adults. 95 (42.4%) strongly disagree/disagree and 49 (21.9%) remain neutral.
- Out of 220 responses; 75 (34.1%) people strongly agree/agree that they are satisfied with the general condition of the existing facilities. 71 (32.2%) strongly disagree/disagree and 74 (33.6%) remain neutral.
- Comments include; the need for tennis courts ,bike/walking paths ,skateboard park ,basketball courts, a recreation area for teens and for better upkeep of existing town fields and parks.

## 8. Please rate the need you feel for the following recreational facilities.

- The top ten areas of importance that are very much needed/needed are as follows; bike trail, hiking and skiing
  trails, conservation areas, environmental education, running/jogging, boating/canoeing, basketball courts,
  recreation center and sport fields.
- Top comments included the need for bike trails, swimming area ,,tennis courts, basketball court, dog park, golf/miniature golf and the upgrade/create neighborhood playgrounds.

### 9. How often do you visit the following in Townsend for recreation?

The **top five visited recreational areas** in Townsend are as follows; Town Common, Library, Squannacook River, Willard Brook State Park, and State Walking Trails.

Many commented on not knowing where the areas were that were listed; especially Basbanes Trail, Squannacook Meadows and Howard Park.

# 10. If you feel improvement is needed in Townsend for bicycling and walking from one place to another, then an important aspect would be to:

- The majority of the people felt the need to build more sidewalks for those bicycling and walking from one place to another.
- Improving pedestrian and bicycle access in our town is a top recreational priority in our town. The following all got very strong support in the survey:
  - o Adding more sidewalks
  - o Building the proposed rail trail
  - o Finding safe routes to schools

## 11. Maintenance of existing town Open Space and Recreation Areas should be accomplished through:

- Donations ranked highest for funding
- Volunteers for maintenance
- Taxes were the least supported for either funding or maintenance.

# 12. Would you be willing to participate in the maintenance and development of Townsend's recreation and open space facilities?

- Most responders would be willing to "occasionally" assist with local recreation and open space facilities.
- a good percentage would be willing to sometimes participate in maintenance work, but not too many were interested in serving on a committee to accomplish this

## 13. Water supply protection

A majority of respondents were in favor of protecting our ground water resources, but could benefit from **education** with regard to water source cycle and how their activities affect the outcome.

Some respondents need to know where to obtain information on alternative fertilizers and pesticides, and information on individual wells.

## 14. Historic assets in Townsend

- 5 respondents were not historically minded
- 6 respondents would like to see more local history taught in our schools, and more information on Townsend's history available for newcomers.
- 5 respondents would like to see historical areas and properties preserved, if possible. Some would like the center brought back to look more colonial.
- 2 respondents would like trails through our historic areas, off the main roads. Picnic areas at the Harbor Pond were suggested.
- 2 respondents would like maps of the historic areas available.
- Only 60% of the total survey respondents care that our town history be preserved for the future.

- 25. There are many existing organizations in the town that, if they worked together, could make a strong impact on the recreational options for all residents of Townsend. These include the Recreation Department, Townsend Recreational Activity Council, the Boy and Girl Scouts, the Council on Aging, Kids Kountry Playground, the schools and many others.
- 26. Need the rail trail
- 27. My children are almost adults so we don't use much recreational facilities in town anymore. It would be nice to have some type of teen center like Lunenburg does.
- 28. I understand the need for recreation ...but I believe our schools need to work hand and hand with the recreation department, why should we pay double taxes to build facilities for children, Recreation programs are outside of school hours and the recreation department should have full access to the buildings.
- 29. when we move to townsend in 1983 we had 3 tennis courts.. (i dont play tennis, this did not really make any impact on me) but...we never maintained any of them...we now have one at HBMS, which i belive there are huge cracks.. The one downside in this town is the inability to maintain anything. I was really excited about the possible rail trail, but townsend being townsend....we would never maintain it, and the trail would be as an embarassment as Townsend Hill Road...a real road.!
- 30. The town needs to support the people and especially the children of this community and see what they can do to get a recreational facility.
- 31. I haven't made as much use of the recreation facilities as I would like, thus I feel relatively uninformed to answer this question.
- 32. Our recreational fields are horrible. I have been told by coaches of other towns that are fields are not fit for games. I have showed up to volunteer days and turned mulch, attempt to deweed baseball fields, flipped bleechers to clean up the mess, warned parents of broken seating, donated bee spray to rid nest at parks and schools, and a lot more. I have a comment that I continuously announce each time I labor at one of these sites and it is this, "I will gladly vote for any chairperson or selectmen/women that shows up with a wrake or shovel to help." When it comes time to vote there are signs and picketers everywhere, but when we need lines put on a field, grass mowed, or spring clean up Townsend Town Hall turns its back.
- 33. Rail trail, please! and tennis courtsand skateboard park, at minimum.
- 34. We need a place for teens!
- 35. I take my daughter to neighboring towns due to the lack of attractive outdoor facilities here for young ones. WE DO LOVE OUR NEW LIBRARY, however! Would love to see adult recreational activities such as yoga, pilates, water aerobics, Jazzercize, kick-boxing with classes that are actually held in town
- 36. My children are 4-legged. I think there are enough facilities for 2-legged children. I actually use less of the tax dollar that I pay than those who have 2-legged children. I would like a permanent dog-only park. Currently, I use the former tennis courts at the middle school, but I have to close very poorly maintained chain-link doors to do this. I think someone who lives in the area uses one of the tennis courts as a shortcut for their dirt bike use. Considering I've been harassed by another dirt bike user in my neighborhood who started buzzing my home after I complained to the police because they were using their dirt bike in an area where it is not legal, I am emphatic about creating a dog-friendly area in the town.
- 37. I think more places for teen's would be great a skate park ?? Not sure if this falls within the realm of this survey
- 38. People need to do more for themselves instead of the town having to supply it for them
- 39. I know there are halls and such for adults to use, but there is usually a fee. It would be a tremendous benefit to the town to have a community recreation center at least for the young adults of the town. Not sure what the adults would need.
- 40. Townsend kids..AND TEENS need places for recreation. We have nothing here for them, and no way for them to get anywhere.
- 41. This needs to be balanced against available funds without becoming class warfare(seniors vs youth). in the end the youth always outlast the seniors then they get theirs.

For the very young we have some good facilities at Kids Kountry and the schools after hours. For the age 10-18 crowd we have nothing. We have some for-fee organized sports and one basketball court at Spaulding. We need basketball and tennis courts around town as well as open space for pick-up baseball, football and volleyball - just open fields with cut grass. These kids have no place to go. Monitoring of youngsters facebook pages indicates there are a lot of troubled kids in town who might not be if they had something to do. We, the adults, do not have to organize everything for them We do need to make facilities available so that the kids can develop normally. Since the schools won't let them run at lunch and they can only play sports for a fee, these kids are being denied the fundamental childhood pleasures of being able to run around, play rough and even get hurt. The result is that they turn to available pleasures such as facebook, sex and drugs.

- 2. The new library/senior center is situated on Dudley Road. However, there isn't a safe place to walk on Dudley Road to reach the library or senior center. Considering the retirement home is a few doors down, its a missed opportunity for seniors and their neighbors.
- 3. The rail trail would alleviate many issues with bikes, kids, and people on the busy Rt. 119. Much safer for all!
- 4. The rail trail is a must. The town should move ahead with this without delay. Other biking areas would add tremendously to the desirability of Townsend.
- 5. Stop cars on 119 who won't stop for pedestrians. Very Dangerous!!
- 6. The safer you can make the roads maybe we will see children become more active riding bikes. The safer we make athletic facilities and or town recreation centers maybe more children will get back into sports.

- 7. It would be great to have the trains out here again, but if that is impossible, then turning it into a rail trail would be great. Widening town roads would only increase the speed limit. State roads should be widened because bikers use them all the time and it is very dangerous. Bike lanes might help. A sidewalk along 119 would be great too
- 8. I would like to have sidewalks on the highways. It is very dangerous to walk along these roads. This is more important than a rail to trail path.
- 9. Children living a mile or less from school have been encouraged to walk to school but the town has not provided a safe place (aka sidewalks) for them to walk to NMRS for instance.
- 10. Well-maintained sidewalks among the center of town on major roads would be helpful to create more of a small town community feeling, which Townsend is lacking. Groton's downtown is a great example of a small downtown with a real small, close-knit community feeling; with the sidewalks throughout downtown Groton, community members are encouraged to walk from shop to shop downtown or simply to stroll through downtown. It creates such a nice small town feeling. It also helps to bring up local real estate value.
- 11. Bicycle and pedestrian safety comes well engineered trails and sidewalks, not from stricter speed limit enforcement.
- 14. I would not allow my children to bike on Rt 119 even with a bike lane as the traffic is too heavy and the speed limit is too fast to safely allow biking. I think more children and adults would walk if there was a safer avenue for them to walk on. My husband and I would love to be able to walk from Timberlee park to the center but it is not possible to do that now in a safe and pleasant manner.
- 15. Money appropriated for sidewalk engineering has never been done!!
- 16. I walk and/or bicycle in Townsend almost every day and I am appalled at how biased we are towards getting places by driving. What few sidewalks we have go a mile or so and then stop in the middle of nowhere. What few crosswalks we have go from a parking lot to a church or funeral parlor. There is not even a crosswalk to town hall, without pressing the light and stopping multiple lanes of traffic at a major intersection. In winter, the sidewalks around the town common and the schools are not cleared after snowfalls. We need to become a more walking-friendly town.
- 17. Safety has to be the issue. If there are areas that can be used where bikes do not have to compete with cars (and trucks) that is a good situation.

I would take my kids to the center of town / library / playground more often via bike from Timberly park if I did not have to take them on 119. Given the speed and traffic on 119 I do not take them to the center on Bike. It would also allow people from the center / west townsend access via bike to the Harbor and activities on this side of town.

Volunteer days would be good with a free town pick up or a call number to report large or dangerous items that have been dropped off on the side of the road. I pick up trash regularly but get frustrated with the large items I can not remove personally and I pay for the hazardous material I pick up as well as the tires and lamps.

- 5. I know very little about Townsend from an Historical account and enjoyed talking to one of the gentlemen at the town hall one afternoon about some of the historic information.
- 6. Townsend has a lot of offer antiquing, outdoor rec, but we need to focus more on preserving our heritage and improving our landscape architecture.
- 7. The colonial village aspect has been lost along Route 119 as it has be come a semi-strip mall from the Center towards the Harbor. One way to return to a more rural setting is to have Routes 13 and 119 by pass the center of town as they did in Milford with Rte 101 going around the town center.
