# 2.2 - 7:25pm RDA - TWB #2024-164

Applicant: Alfred Deprato Location: 97 Main St

Project/Status: The removal and replacement of a parking area with new asphalt. Removal of overgrown vegetation and invasive species ~20' from building around the sides and rear of the building. Demolition of an existing 4'X12' dilapidated structure. Work is within 100' of a perennial stream.

### 2.3 - 7:40pm RDA - TWB #2024-165

Applicant: Nashua River Watershed Association

Rep: Jessica Veysey Powell, (NRWS)

Location: 42 & 22 West Meadow Rd

Project/Status: The NRWA will plant about 325 native bare root tree or shrub seedlings along Locke Brook which runs through two abutting properties (42 & 22 W meadow). These plantings are intended to increase shade, reduce bank erosion and provide additional sedimentation filtration from runoff. Work will take place within the 35' no disturb buffer.

Applicant: Nashua River Watershed Association Location: 0 Riverbank Terrace – Adams Dam

Project/Status: The NRWA will plant about 120 native bare root tree or shrub seedlings along the unvegetated sections of riverbank at Adams Dam to reduce erosion of the steep bank along the trail. Work will take place within the 35' no disturb buffer.

Applicant: Townsend Historical Society

Rep: Chris Mackenzie(Dillis & Roy)

Location: 65 Main Street

Project/Status: The proposed project is for the installation of a septic system tight tank and building addition with associated site grading. Work is proposed within 100' of Resource Areas and within 35' no disturb buffer. Also, the proposed tight tank is proposed less than 10 feet from the 100 year flood hazard zone.
