Can you please confirm a review of Chief Eaton's computer, hard copy files, and emails has been conducted to locate this document? Also, can you please confirm that you have checked with the two officers identified in the DCJIS report who are currently employed by the TPD (Officers Rochette and Gyles) to determine if they can locate the statements they provided to Chief Eaton, which were then sent along to DCJIS.

Also, can you please provide me with any emails between town counsel, James Kreidler, the BOS and Chief Eaton (or any combination thereof) regarding providing this investigation report and/or the statements from the four identified TPD employees from October 1, 2016 to February 28, 2017?
