Attached is my proposed fiscal year 2017 budget for the Board's consideration and direction in accordance with the instructions received by Interim Town Administrator Jim Kreidler.

Personnel: Salaries & Wages

As instructed a 21/2% increase in has been factored into the salaries and wages for all union and non-union employees. However, these amounts may change as the Highway/Water Department Union contract expires on June 30, 2016 and negotiations have yet to begin. Also, a request for recognition for a Supervisory union has been received by the Board of Selectmen but, to date has not been accepted. This also, may require changes to salary & wages. The Selectmen have yet to decide whether the 21/2% increase will reflect a cost of living adjustment (COLA) or a step increase. The Superintendent's salary will appear to be significantly over the recommended 21/2%. This is due to the recommendation of the State Ethics Commission because of the Superintendent's involvement in the budget process in submitting the budget to the Board of Water Commissioners. The State Ethics Commission recommends on call compensation for the Superintendent be included in the base salary. It should be noted that although the Superintendent's base salary and wages appears to increase 8.71% the total reflects a 2.51%

increase as recommended. Similarly, the Water Technicians and Office Administrators base salary complies with the recommended 2½% increase. However, the total Salary and wage for each position may reflect a slightly higher or lower amount. This is due to the amount of weeks scheduled to be on call and the amount of holidays on call in keeping with the same rotation or an increase in longevity pay. Again the budget includes funding for an additional Water Technician. Although approved at last year's Town Meeting the Selectmen delayed approval to fill the position pending a report on a formation of a Department of Public Works (DPW). Also, funding was included to hire a Temporary/Part Time Billing Clerk to assist in clerical duties while the Office Administrator is out on medical leave.

Expenses:

As recommended, for the most part we have level funded of our "expense" portion of the budget. The only increase is for maintenance and repair of critical components such as radio units and Programmable Logic Controllers (PLC's) within our recently completed SCADA system which allows us to remotely monitor and run the system more effectively and efficiently. Also, there will be a \$20,000.00 decrease in the Expense part of the budget as per Town Accountant as the Emergency Reserve Fund should be included in "Special Articles" so, that was changed.

Special Projects and Articles:

It was recommended by the Town Accountant that the Board of Water Commissioners vote to close-out several accounts at the end of the fiscal year to clean things up. These included:

Closing out of these accounts would put the unexpended balance into "Retained Earnings" or "Surplus" at the end of the fiscal year. As customarily done per our enabling act, the bulk of "Surplus" is transferred into System Enhancements to be used in New Construction. Currently we have an unexpended balance of \$876,375.92 in System Enhancements. After closing out of the

above accounts and transferred into System Enhancements there would be an unexpended balance of \$1,076,542.26. In addition, because FY15 is not yet closed out and amounts certified this amount could increase by approximately \$200,000.00 (FY15 Surplus) totaling \$1,276,542.26.

Special Projects and Articles: Cont.

With a number of projects the board has voted to move forward on the costs of which will reduce the System Enhancement amount, i.e., Repair and Maintenance of the Fitchburg Rd, Tank could cost \$200,000-\$400,000. Resolving the Cross St. Station water quality issue is unknown and, the repairs to the Witch's Brook Well 1 is already budgeted for in the Special Articles. The Board should consider other projects or lower water rates per our Enabling Acts of 1920.
