Jack said we can reduce our budget by 5-10% if we give up the maintenance of the hydrants. Jack would like level funded with 2.5% raise for superintendent.

<u>DECISION</u>: The Board voted unanimously to approve \$797,675.00 for FY 11 budget which is level-funded with 2.5% raise for superintendent.
